

# CERTIFIED CORNER RECORDATION

CORNER NW Sec. Cor. S 13 T. 27 N., R. 29 W., P.M.M. LINCOLN COUNTY

## RECORD:

1903 original GLO notes by William K. Trippet.

"A shale stone 20 x 12 x 4 ins., 15 ins. in the ground, for the cor. of secs. 11,12,13, and 14, marked with 1 notch on E., and 4 notches on S. edge; from which .

A Tamarack, 14 ins. in diam., bears N. 62° E., 36 lks. dist., marked T 27 N R 29 W S 12 BT.

A Tamarack, 20 ins. in diam., bears S. 35° E., 20 lks. dist., marked T 27 N R 30 W S 12 BT.

A Tamarack, 18 ins. in diam., bears S. 28° W., 35 lks. dist., marked T 27 N R 29 W S 14 BT.

A fir, 14 ins. in diam., bears N. 30° W, 30 lks. dist., marked T 27 N R 29 W S 11 BT."

## FOUND EVIDENCE:

Found original stone and three (3) BT's.

A 10 inch DBH Grand Fir scribed T 27 N R 29 W S 14 BT. bears S 52° W 3.2 feet.

A 20 inch DBH Tamarack scribed T 27 N R 29 W S 13 bears S 35° E 13.2 feet.

A 17 inch DBH Douglas Fir scribed T 27 N R 29 W S 12 bears N 35° E 15.1 feet.

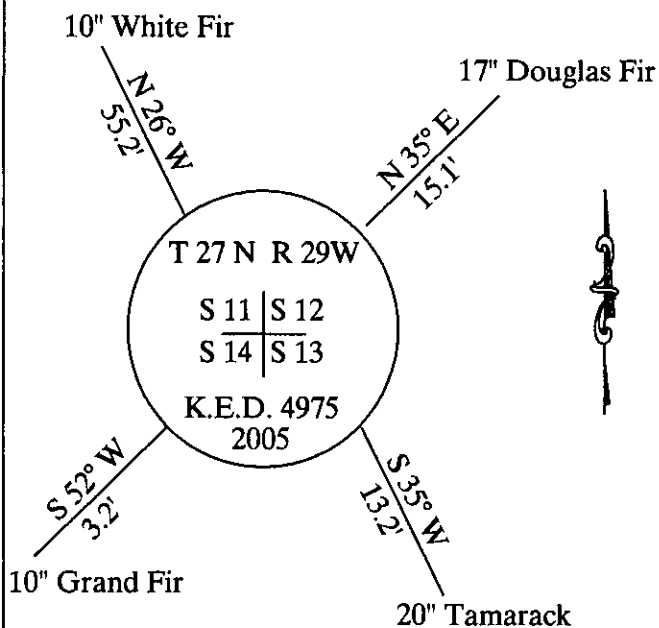
## PERPETUATION:

Replaced original stone with a 3 1/4 inch aluminum cap stamped (see diagram below) on a 5/8 inch dia. rebar 30 inches long. From which:

A 10 inch DBH White Fir scribed T 27 N R 28 W S 11 bears N 26° W 55.2 feet.

Painted 6 inch wide band with attached bearing tree signs to all trees.

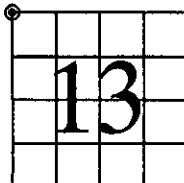
