Christiansen: "The 1/4 cor. of secs. 23 and 26, monumented with a limestone, 20x8x2 ins. firmly set 15 ins. in the ground, mkd. 1/4 on the N. face, and witnessed by the remains of the original bearing trees: A larch stump, 12 ins. diam., bears N32 $3/4^{\circ}$ E, 24 lks. dist., with an overgrown blaze. A dead larch, 20 ins. diam., bears S30 W, 55 lks. dist., with an overgrown blaze.

At the corner point; set an iron post, 30 ins. long, 2 1/2 ins. diam., 22 ins. in the ground, with brass cap mkd.


