
## CERTIFIED CORNER RECORDATION

Corner S.C. Secs. 19 & 30 T. 28N R. 27W P.M., MT Lincoln County

I. <u>1891 G.L.O.</u> Record by Newton Orr: Set a limestone, 20x10x5 ins., 15 ins. in the ground, for cor. to secs. 19,24,25 & 30, mkd. with 4 notches on the N. and 2 notches on the S. edges. Established four bearing trees.

1902 Retracement Survey Record by Burton S. Adams et. al.: Intersect E. bdy. of Tp., 1.46 chs., N. of the cor. of secs. 19,24,25 and 30, which is a stone 10x5, 5 ins. above ground, mkd. and witnessed as described by the surveyor general, as this cor. will hereafter refer to secs. 19 and 30 only, I efface the marks from the S.W. and N.W. bearing trees.

1970 B.L.M. Record by Joseph E. French: The cor. of secs. 19 and 30, on the W. bdy. of the Tp., monumented with a limestone, 20x10x5 ins., firmly set, mkd. with 4 notches on the N. and 2 notches on the S. edges, and witnessed by the remains of the original bearing trees. At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 24 ins. in the ground, with a brass cap, mkd. as shown.



Established one new bearing tree and bury the original stone alongside the iron post.

II. Found a 2 1/2 in. diam. iron pipe, firmly set, protruding 4 ins. above the ground, with a 3 1/4 in. diam. brass cap, mkd. as shown, and witnessed by the remains of the original bearing trees and the B.L.M. bearing tree.

from which:

A down larch snag, 24 ins. diam., bears N34°E, 85.8 ft. dist., with visible scribe. (GLO-record)

A larch stump, 31 ins. diam., bears S07°E, 35.7 ft. dist., no visible scribe. (GLO-record)

A larch, 9 ins. diam., bears \$73°E, 45.5 ft. dist., with a healed face. (BLM-record)

A pine snag, 18 ins. diam., bears S54°W, 46.8 ft. dist., no visible scribe. (GLO-record)


A larch stump, 39 ins. diam., bears N49°W, 30.4 ft. dist., no visible scribe. (GLO-record)

III. Established one new bearing tree and set a post:

A lodgepole pine, 6 ins. diam., bears N32°E, 48.2 ft. dist., mkd. "T28N R27W S19 BT".

A 6 ft. galvanized steel guard post, N., 3.0 ft. dist. of corner, with a Land Survey Monument decal attached.

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs. Magnetic Declination: 20° East


