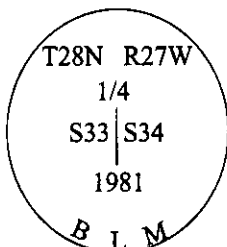


CERTIFIED CORNER RECORDATION

Corner 1/4 Secs. 33&34 T. 28N R. 27W P.M., MT Lincoln County
Flathead County

I. 1891 G.L.O. Original Record by Newton Orr: Set a post, 4 ft. long, 4 ins. square, 24 ins. in the ground for 1/4 sec. cor. mkd. "1/4 S" on the W. face. Established two bearing trees.

1981 B.L.M. Remonumentation Record by Joseph E. French: The 1/4 sec. cor. of secs. 33 & 34, monumented with the decayed remains of the original wood post, and witnessed by the remains of the original bearing trees. At the corner point, set an aluminum post, 30 ins. long, 2 1/2 ins. diam., 24 ins. in the ground, with aluminum cap mkd. as shown:



Established one new bearing tree:

A pine, 9 ins. diam., bears S72 1/4°W, 82 lks. dist., mkd. "1/4 S33 BT".

II. Found a 2 1/2 in. diam. aluminum pipe, protruding 10 ins. above the ground, with a 3 1/4 in. diam. B.L.M. aluminum cap, mkd. as shown above.

from which:

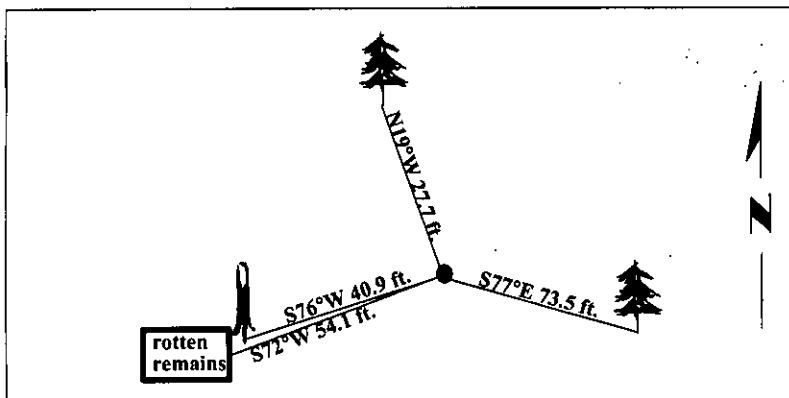
- A larch, 27 ins. diam., bears S77°E, 73.5 ft. dist., "1/4 S" visible. (GLO-record)
- Rotten remains, bears S72°W, 54.1 ft. dist. "1/4 S33 BT" visible. (BLM-record)
- A dead pine, 7 ins. diam., bears S76°W, 40.9 ft. dist. "1/4 S BT" visible. (GLO-record)

III. Established one new bearing tree:

A pine, 5 ins. diam., bears N19°W, 27.7 ft. dist., mkd. "1/4 S33 BT".

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.
