

- I. 1908 G.L.O. Original Record by Edwin R. McLain: Set a slate stone, 14x8x5 ins., 10 ins. in the ground for 1/4 sec. cor. mkd. "1/4" on the W. face. Established two bearing trees.
- II. Found a stone, 8x4 ins., 7 ins., above the ground, mkd. "1/4" on the W. face.

from which:

A fir snag, 15 ins. diam., bears S35°E, 13.2 ft. dist., with visible scribe. (GLO-record) No evidence of the other bearing tree found.

III. At the postition of the found stone, set in its place, an aluminum pipe, 30 ins. long, 2 1/2 in. diam., 22 ins. in the ground, with a 3 1/4 in. diam. aluminum cap, mkd. as shown:




Established two bearing trees:

A fir, 10 ins. diam., bears N61°E, 22.1 ft. dist., mkd. "1/4 S34 BT". A fir, 15 ins. diam., bears N12°W, 11.3 ft. dist., mkd. "1/4 S33 BT".

Buried the original stone alongside the alumunim pipe.

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.
