

I. 1893 G.L.O. Original Record by James S. Keerl et. al.: Set a limestone, 16x10x6 ins., 11 ins. in the ground, for 1/4 sec. cor., mkd. "1/4" on the N. face.

Established two bearing trees:

A larch, 24 ins. diam., bears S43°E, 55 lks. dist., mkd. "1/4 S BT". A white pine, 10 ins. diam., bears N53°W, 14 lks. dist., mkd. "1/4 S BT".

1982 B.L.M. Remonumentation Record by Cruz D. Almanza: For the 1/4 sec. cor. of secs. 2 & 11, monumented with a limestone, 16x10x6 ins., firmly set, 11 ins. in the ground, mkd. "1/4" on the N. face and witnessed by the remains of the original S.E. bearing tree. Set an aluminum post, 30 ins. long, 2 1/2 ins. in diam., 22 ins. in the ground, with aluminum cap mkd. as shown:



Established two new bearing trees:

A fir, 6 ins. diam., bears S60 1/4°W, 24 lks. dist., mkd. "1/4 S11 BT".

A larch, 6 ins. diam., bears N11 3/4°W, 62 lks. dist., mkd. "1/4 S2 BT".

Bury the original stone alongside the aluminum post.

1982 Certified Corner Recordation by William Condrey No. 5425S: Found aluminum post, 2 1/2 ins. in diam., with a BLM aluminum cap, witnessed by both BLM bearing trees, mkd. as described in the BLM records. Set a fiberglass post alongside of corner.

II. Found a 2 1/2 in. diam. aluminum pipe, protruding 6 ins. above the ground, with a 3 1/4 in. diam. aluminum cap mkd. as shown above.

from which:


A fir, 6 ins. diam., bears S60°W, 16.0 ft. dist. (BLM-record mkd. "1/4 S11 BT".) A larch, 6 ins. diam., bears N12°W, 41.0 ft. dist. (BLM-record mkd. "1/4 S2 BT".) Bearing trees burnt, due to fire.

III. No suitable trees within limits, therefore, from the corner position, I set two posts.

A 6 ft. steel guard post, bears East, on properly line, 5.8 ft. dist. A 6 ft. steel guard post, bears West, on property line, 4.2 ft. dist.

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs. Attached Land Survey Monument and Property Boundary decals to the guard posts.

Magnetic Declination: 20° East.






