

A larch, 12 ins. diam., bears N20°W, 28 lks. dist., mkd. "T29N R26W S2 BT".

1982 B.L.M. Remonumentation Record by Cruz D. Almanza: The cor. of secs. 1,2,11&12, monumented with a sandstone, 16x10x9 ins., firmly set, mkd. as described in the original record and witnessed by two of the original bearing trees. At the corner point, set an aluminum post, 30 ins. long, 2 1/2 ins. in diam., 22 ins. in the ground, with aluminum cap mkd. as shown:


