

Established two bearing trees:

A larch, 7 ins. diam., bears S81°E, 27 lks. dist., mkd. "1/4 S BT".

A fir, 6 ins. diam., bears N17°W, 18 lks. dist., mkd. "1/4 S BT".

1983 Certified Corner Recordation by William Condrey No. 5425S: No physical evidence of the original corner and bearing trees could be found. Established position by proportionate measurement. Set an aluminum post, 30 ins. long, 2 1/2 ins. in diam., 22 ins. in the ground, with a 3 in. diam. aluminum cap mkd. as shown:



Established two new bearing trees:

A fir, 10 ins. diam., bears N71 1/2°E, 7.0 ft. dist., mkd. "1/4 S2 BT".

A fir, 7 ins. diam., bears S72°W, 10.7 ft. dist., mkd. "1/4 S3 BT".

Built a stone mound around the aluminum post. Set a 6 ft. carsonite post alongside the aluminum post.

II. Found a 2 1/2 in. diam. aluminum pipe, protruding 6 ins. above a small rock collar, firmly set, with a 3 1/2 in. diam. aluminum cap mkd. as shown above.



Painted bearing trees and attached Land Survey Monument and Bearing Tree signs. Attached Land Survey Monument and Property Boundary decals to the guard post.


