## CERTIFIED CORNER RECORDATION

Corner E 1/4 29N R. 26W P.M., MT Sec. Lincoln County

I. 1893 G.L.O. Original Record by P. McCardell et. al.: Set a sandstone, 12X8X6 ins., 8 ins. in the ground, for 1/4 sec. cor. mkd. "1/4" on the N. face.

Established two bearing trees:

A larch, 12 ins. diam., bears S13°E, 10 lks. dist., mkd. "1/4 S BT".


A yellow pine, 14 ins. diam., bears N38°W, 17 lks. dist., mkd. "1/4 S BT".

1932 B.L.M. Resurvey of the Horse Plains Guide Meridian by Fred L. Cumming et. al.: Intersect the old 1/4 sec. cor., which is a sandstone, firmly set, mkd. and witnessed as described in the original record, except that the N.W. tree is dead. This corner will hereafter refer to sec. 13 only. Effaced the markings from the old tree in sec. 18. Established two new bearing trees:

A lodgepole pine, 10 ins. diam., bears S88°W, 42 lks. dist., mkd. "1/4 S13 BT".

A fir, 10 ins. diam., bears N48 3/4°W, 40 lks. dist., mkd. "1/4 S13 BT".

1982 B.L.M. Remonumentation Record by Cruz D. Almanza: The 1/4 sec. cor. of sec. 13, only, monumented with a sandstone, firmly set, mkd. as described in the original record and witnessed by the 1932 N.W. bearing tree. The S.W. bearing tree is dead. At the corner point, set an aluminum post, 30 ins. long, 2 1/2 ins. in diam., 22 ins. in the ground, with aluminum cap mkd as shown:



Established one new bearing tree:

A fir, 6 ins. diam., bears S68 1/4°W, 30 lks. dist., mkd. "X" "BT".

Bury the original stone alongside and raise a collar of stone, 3 ft. diam., around the aluminum post.

1983 Certified Corner Recordation by William Condrey No. 5425S. Found a 2 1/2 in. diam. aluminum post, with cap mkd. as described in the 1982 BLM record and witnessed by the N.W. bearing tree, set in 1932 and the S.W. bearing tree, set in 1982.

Found a 2 1/2 in. diam. aluminum pipe, protruding 10 ins. above a mound of stone, with a 3 1/4 in. diam. aluminum cap mkd. II. as shown above. from which:

> A burned dead fir, 7 ins. diam., bears S68°W, 30 lks. (19.8) ft. dist., mkd. with a healed face." (1982 BLM-record) A burned fir stump, 26 ins. diam., bears N49°W, 40 lks. (26.4) ft. dist., (1932 BLM-record)


III. No suitable trees within limits, therefore, from the corner point, I set two posts:

A 6 ft. steel guard post, bears North, on property line, 3.4 ft. dist.

A 6 ft. steel guard post, bears South, on property line, 3.4 ft. dist. Built up a mound of stone around the monument, 1.5 ft. high, 2 ins. in diam.
