Closing corner common to Sec. 5 and 6, T29N, R27W, MPM. Found original stone firmly set and marked (Record - set a trachite stone,  $20 \times 10 \times 8$  ins., 15 ins. in the ground, for closing cor. of Secs. 5 and 6, marked CC on S., with 5 grooves on E. and 1 groove on W. faces; from which:

A fir, 12 in. diam., bears S  $39\frac{1}{2}$ E - 70 Lks. Dist. stump with blaze (Record - a fir, 8 in. diam., bears S  $39^{\circ}15^{\circ}E$  - 70 Lks. Dist., marked T29N, R27W, S 5 BT.)

A fir, 8 in. diam., bears S  $76\frac{1}{2}$ W - 26 Lks. Dist., stump with scribing visible, (Record - a fir 7 in. diam., bears S  $76^{\circ}15$ 'W., 26 Lks. Dist. marked T29N, R27W S 6 BT).

## DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

For the closing cor. common to Sec. 5 and 6, T29N, R27W, MPM, I set a 2 in. galvanized iron pipe 24 ins. in the ground, with brass cap marked. I set corner in exact center point of original stone. From which:

A 6 in. ponderosa pine bears S  $72^{10}_{2}$ W - 40 Lks. Dist. marked RM.

A 9 in. ponderosa pine bears N 682°W - 112 Lks. Dist. marked RM.

I placed signs and paint on RM's and at corner.
