Raise a flat mound of stone 3 ft. diam. around the iron post

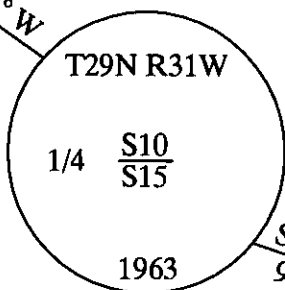

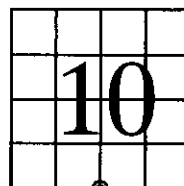
