

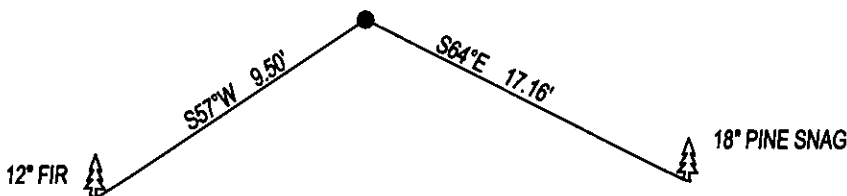

 13" PINE BEARS S60 1/2°W, 19.80 SCRIBED 1/4 S BT.

FOUND: NO EVIDENCE OF ORIGINAL STONE, CORNER POSITION FALLS IN SKID TRAIL.
 FOUND 18" PINE SNAG BEARS S64°E, 17.16 SCRIBED 1/4 S BT.

MAINTENANCE: REESTABLISHED CORNER POSITION FROM PINE SNAG AND SET
 5/8"x24" REBAR WITH YELLOW PLASTIC CAP STAMPED AS SHOWN, FROM WHICH;
 NEW BT, 12" FIR BEARS S57°W 9.50' SCRIBED RM.
 SET STEEL POST 1 FOOT SOUTH, PAINTED RED BANDS ON BTS.

SKETCH OF CORNER

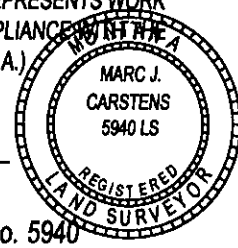

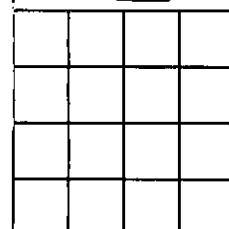
