

1965 B.L.M. remonumentation record by Duane C. Lindenberg: "The cor. of secs. 7, 12, 13, and 18, on the W. bdy. of the tp., monumented with a slate stone, $16 \times 8 \times 6$ ins., firmly set, marked with 4 notches on the S. and 2 notches on the N. edges and witnessed by the original bearing trees. At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 26 ins. in the ground, with brass cap mkd.

A pine, 27 ins. diam., bears N8 10'E, 320 lks. dist., mkd. T30N R29W S7 BT. (Record)
A pine, 30 ins. diam., bears S49 20'E, 93 lks. dist., mkd. T30N R29W S18 BT. (Record)
A pine, 26 ins. diam., bears N44 w, 262 lks. dist., mkd. T30N R30W S12 BT. (Record)

The new bearing trees:

A pine, 12 ins. diam., bears N72 $1/2^{\circ}$ W, 104 lks. dist., mkd. X BT.

Bury the original stone alongside the iron post."

II. Found, a 2 1/2 in. dia. iron pipe, 2 ins. out of ground with a 3 1/4 in. dia., B.L.M. brass cap marked as shown above, from which

A ponderosa pine, 26 ins. diam., bears $N11^{\circ}E$, 211.9 ft. (321.0 lks.) dist., scribe R29 is visible. (G.L.O.)


A stump hole with log, 29 ins. diam., bears \$46°E, 61.4 ft. (93.0 lks.) dist., scribe is visible. (G.L.O.)

A ponderosa pine, 21 ins. diam., bears N71°W, 68.9 ft. (104.4 lks.) dist., scribe overgrown. (B.L.M.)

A ponderosa pine snag, 26 ins. diam., bears N40°W, 172.2 ft. (260.9 lks.) dist., all scribe visible. (B.L.M.)
