

CERTIFIED CORNER RECORDATION

Corner 1/4 Secs. 19 & 30 T. 30 N. R. 33 W. P.M.M. LINCOLN County

I. Record:

1893 original record by Daniel P. Mumbrue: 38.41 chains, "Set a post 3 ft. long, 3 ins. square, 24 ins. in the ground, for 1/4 sec. cor., marked 1/4 S., on N. face; from which:
A fir, 12 ins. diam., bears N11 3/4°W, 31 lks. distant marked 1/4 S BT.
A fir, 9 ins. diam., bears S53°E, 35 lks. distant marked 1/4 S BT.

1978 Certified Corner Recordation by Melvin D. Lauteren: No evidence found. Set by single proportion. The N 1/4 corner of Section 30, T30N, R33W, P.M.M. is a 2"x24" steel pipe and a brass cap placed 24" into the ground, stamped as shown, from which:

A 2.0' diam. pine (yellow), bears N25°W, a distance of 38.30 feet., scribed 1/4 S19 BT.
A 1.6' diam. red fir, bears S10°W, a distance of 64.15 feet, scribed 1/4 S 30 BT.



II. Found a 2 1/2 in. diam. brass cap, flush with the ground, mkd. as shown, from which:

A pine, 28 ins. diam., bears N25°W, 38.3 ft. dist. mkd. 1/4 S19 BT.
A fir, 20 ins. diam., bears S10°W, 64.1 ft. dist., mkd. with a healed face.



NOTE: No record of when "1997" was added to the cap.

III. Set a 6 ft. galvanized steel guard post 3.0 ft. north, with Property Boundary and Land Survey Monument decals attached. Attached Bearing Tree and Land Survey Monument signs to the bearing trees. Painted red bands around the bearing trees.

SKETCH OF CORNER

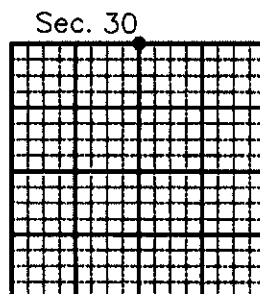
