

1893 original, G.L.O. record by Daniel P. Mumbrue: Set a wood post with four bearing trees.

1913 resurvey, G.L.O. record by Lewellyn D. Lyman et al: Set a stone and raise a mound of stone.

1970 B.L.M. remonumentation by Joseph E. French: "The cor. of secs. 6 and 7, on the W. bdy. of the Tp., monumented with a limestone, 22x20x8 ins., firmly set, mkd. with 5 notches on the S. and 1 notch on the N. edges, and witnessed by a mound of stone E. of the cor. At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 24 ins. in the ground, with brass cap mkd.



from which

A pine, 6 ins. diam., bears ${\bf 568}^{\rm o}{\rm E}$, 58 lks. dist., mkd. T30N R33W S7 BT.

Bury the original stone alongside and rebuild the mound of stone, 3 ft. base, 1 1/2 ft. high, E.

- Found a 2 1/2 ins. diam. pipe, in collar of stone, with B.L.M. brass cap mkd. as shown above. No evidence of BLM BT.
- 'III. Establish two new bearing trees:

A fir, 6 ins. diam., bears N61 E, 23.6 ft. dist., mkd. T30N R33W S6 BT. A fir, 8 ins. diam., bears 858° E, 16.0 ft. dist., mkd. T30N R33W S7 BT.

Set a 6 ft. galvanized steel guard post with "Survey Marker" decal attached, 2.8 ft., West.

Painted a red band around each bearing tree and attached "Land Survey Monument" & "Bearing Tree"
