

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

Corner 3 of MS 7655 T. 30 N. R. 34 W. Lincoln County

- I. 1905 MS original record by E.P. Harrison: "A post, 5x5 ins. . 5 ft. long, set 2 ft. deep, scribed 3-7655, Raised a mound of earth around post.

A blazed tamarack tree, 24 ins. in diam., scribed BT 3-7655, bears $N45^{\circ}E$, 3 ft.
A blazed fir tree, 16 ins. in diam., scribed BT 3-7655, bears $S10^{\circ}E$, 11 ft."

- II. Found a post hole with rotten remains.

From which:

A larch, 29 ins. diam., bears $N45^{\circ}E$, 3.0 ft. dist., visible scribing. (Original BT)
A dead fir, 26 ins. diam., bears $S10^{\circ}E$, 11.0 ft. dist., healed face. (Original BT)

- III. Set a $3/4$ in. diam., 30 ins. long. alum. rod 24 ins. in the ground with alum. cap mkd. as shown.

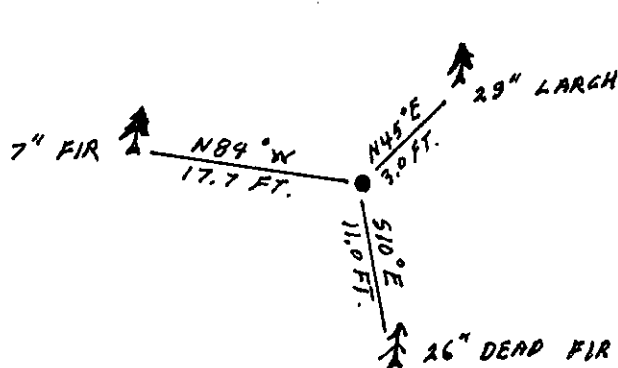


From which:

A fir, 7 ins. diam., bears $N84^{\circ}W$, 17.7 ft. dist., mkd. 3 7655 BT.

Painted red bands around the bearing trees and attached "Land Survey Monument" and "Bearing Tree" signs.

Set a galvanized steel guard post with "Land Survey Marker" and "Property Boundary" decals. $S15^{\circ}W$, 3 ft.
Magnetic declination: 20° East

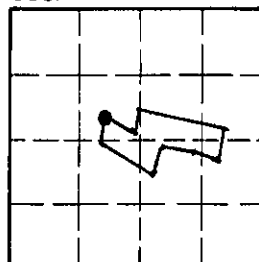
