

I. 1903 G.L.O. Original Record by George A. Fessenden et. al.: Set a slate stone, 12X10X6 ins., 8 ins. in the ground for 1/4 sec. cor. mkd. "1/4" on the W. face. Set two bearing trees.

1982 B.L.M. Remonumentation Record by Cruz D. Almanza.: The 1/4 sec. cor. of secs. 7 and 8, monumented with a slate stone, 12X10X6 ins., lying loose, mkd. "1/4" on a face, witnessed by both original bearing trees.

A larch, 4 ins. diam., bears N86°E, 28 lks. dist., mkd. with an overgrown blaze. (record) A pine, 4 ins. diam., bears N2 1/2°W, 22 lks. dist., mkd. "1/4 S7 BT". (record-A larch tree.)

At the corner point, set an aluminum post, 30 ins. long, 2 1/2 ins. in diam., 8 ins. above the ground, with the aluminum cap mkd. as shown:



Bury the original stone alongside and raise a collar of stone, 2 ft. diam., around the aluminum post.

1985 Certified Corner Recordation by Thomas C. Hill No. 5612 S. Found a BLM monument, protruding 8 ins. above the ground, with an aluminum cap mkd. as described in the the BLM records.

from which:

A larch, 12 ins. diam., bears N85°E, 27.8 lks. dist., mkd. with a healed face. (GLO-record N86°E, 28 lks.) A pine, 6 ins. diam., bears N02°W, 21.1 lks. dist., mkd. with visible scribe. (GLO-record-A larch tree, N2 1/2°E, 22 lks.)

II. Found a 2 1/2 in. diam. aluminum pipe, protruding 3 ins. above the ground, firmly set, with a 3 1/4 in. diam. cap mkd. as shown above.

from which:


A larch, 12 ins. diam., bears N86°E, 18.5 ft. dist., mkd. with a healed face. (GLO-record)
A fallen pine, bears N2 1/2°W, 14.5 ft. dist., mkd. with a healed face. (GLO-record A larch tree)


III. Established one new bearing tree.

A fir, 11 ins. diam., bears N32°W, 29.5 ft. dist., mkd. "1/4 S7 BT".
