

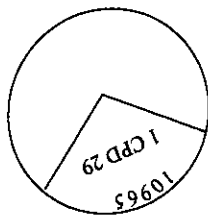
# CERTIFIED CORNER RECORDATION

Corner MS 10965 COR. 1 Sec. 14 T. 31N R. 30W P.M., MT. Lincoln County  
CPD NO. 29 LODE

I. 1976 Original B. L. M. survey by Arthur C. Rader: At cor. No. 1 of the CPD No. 29 lode, set an iron post, 30 ins. long, 1 in. diam., 24 ins. in the ground, with brass cap mkd. 1CP29-10965; from which:

A pine, 12 ins. diam., bears N 69°30' E, 37.66 ft. dist. mkd. 1CPD29-10965 BT.  
A pine, 10 ins. diam., bears S 60°50' W, 47.0 ft. dist., mkd. 1CPD29-10965 BT.  
A cor. of the location bears NORTH, 1.0 ft. dist.

II. Found a 1 1/2 in. diam. iron pipe, 9 ins. above ground, firmly set, with a 3 in. diam. brass cap, mkd. as shown:.

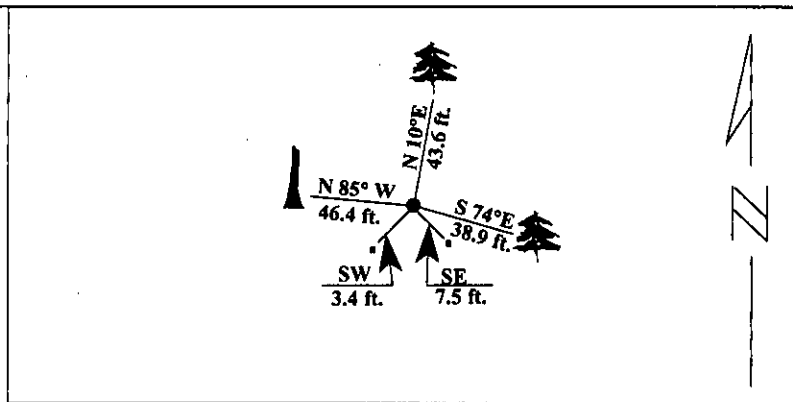
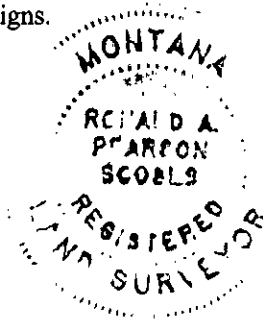
A pine, 13 ins. diam., bears S 74°E, 38.9 ft. dist., mkd. with visible scribe marks. (Rec: N 69°30' E, 37.6 ft.)  
A pine snag, bears N 85°W, 46.4 ft. dist., mkd. with visible scribe marks. (Rec: S 60°50' W)  
A steel post, bears SE, 7.5 ft. dist. with Property Boundary decal attached.  
A steel post, bears SW, 3.4 ft. dist. with Property Boundary decal attached.

III. Established one new bearing tree:

A pine, 23 ins. diam., bears N 10°E, 43.6 ft. dist., mkd. 1 CPD29 10965 BT.

Painted red bands around the bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.

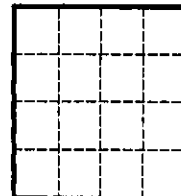
