

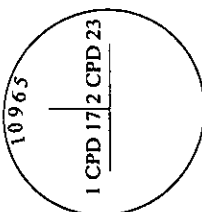
## CERTIFIED CORNER RECORDATION

Corner **MS 10965 COR. 1** Sec. **13** T. **31N** R. **30W** P.M., MT. Lincoln County  
**CPD NO. 17 LODE**

I. 1976 Original B. L. M. survey by Arthur C. Rader: At Cor. No. 1 of the CPD No.17 lode, identical with Cor. No. 2 of the CPD No. 23 lode, of this survey. Set an iron post, 30 ins. long, 1 in. diam., 24 ins. in the ground, with brass cap mkd. 1CPD17 2CPD23-10965; from which:

- A larch, 10 ins. diam., bears S 19°30' E, 29.7 ft. dist. mkd. 1CPD17-10965 BT.
- A pine, 10 ins. diam., bears S 44°10' W, 19.3 ft. dist., mkd. 2CPD23-10965 BT.
- A cor. of the location bears N 42°54' E, 1.0 ft. dist.

II. Found a 1 1/2 in. diam. iron pipe, 12 ins. above ground, firmly set, with a 3 in. diam. brass cap, mkd. as shown:



from which:

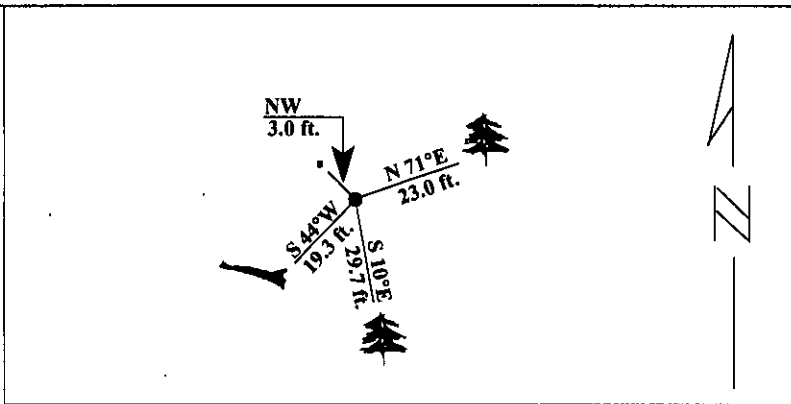
- A larch, 11 ins. diam., bears S 10°E, 29.7 ft. dist., mkd. with visible scribe marks. (Rec: S 19°30' E)
- A down pine, 10 ins. diam., bears S 44°W, 19.3 ft. dist., mkd. with visible scribe marks.
- A steel guard post bears NW, 3 ft. dist., with Property Boundary decal attached.

III. Established one new bearing tree:

- A fir, 22 ins. diam., bears N 71°E, 23.0 ft. dist., mkd. X BT.

Painted red bands around the bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.
