3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Registered Land Surveyor in State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

Corner N1/16th Sections 28, 29 T. 31N R. 31W P.M.M. Lincoln County

At the North 1/16th corner of Sections 28 and 29

Plat of Rawlings Rds. 2nd Addition shows Iron pin 1/16 corner S0°03'E 1320 feet from NE corner of Section 29. Found a 1/4 blazed tree near corner position. No other evidence.

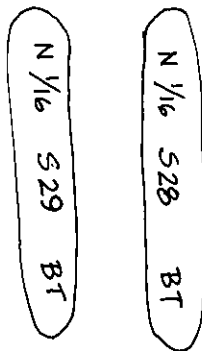
We set a 5/8 inch diameter by 24 inch long rebar with a yellow PVC plastic cap stamped: MDL 4232 S, midway between NE corner and East 1/4 corners of Section 29, from which we established the following bearing trees and tags:

A 12 inch diameter Douglas Fir bears N24°E 12.5 feet to the center of the tree, scribed N 1/16 S 28 BT near the base of the tree.

A 15 inch diameter Ponderosa Pine bears N59°W 23.7 feet to the center of the tree, scribed N 1/16 S 29 BT near the base of the tree.

Both BTs tagged by KEI {LAD and GEB 5/19/82} and painted red.

A 7 inch diameter Lodge Pole Pine bears N45°E 3.5 feet to the center of the tree, with an interior Section Location Poster scratched N1/16 Section 28 T. 31 N., R. 31 W., P.M.M.



1-1/4 inch diameter yellow PVC plastic cap on 5/8 inch by 24 inch rebar.

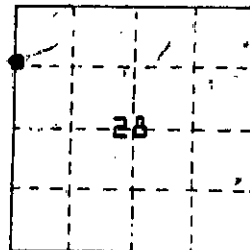
