
CERTIFIED CORNER RECORDATION

SE Sec. Corner P.M, MT Corner Lincoln County

I. 1901 G.L.O. original record: Set a quartz stone and four bearing trees.

> 1963 B.L.M. remonumentation record by Gerald F. Pittman: The corner of secs. 8, 9, 16 and 17, monumented with a stone, 16x8x8 ins., firmly set and mkd. with 4 grooves on the E. and S. faces. Discovered remains of all four orig. bearing trees. At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 26 ins. in the ground, with brass cap marked:



Established 4 new bearing trees.

1986 Certified Corner Recordation filed in the Lincoln County Courthouse by Thomas C. Hill: Found a BLM cap witnessed by four B.L.M. bearing trees and the remains of four orig. bearing trees. Set a guard post with "Survey Marker" decal attached, 2 ft. West from corner.

II. Found a B.L.M. brass cap, 2 in. above ground, firmly set, mkd. as shown above.

from which:

A rotten stump, bears N52°E, 59.8 ft. dist., with visible scribing. (G.L.O.)

A fallen pine, 9 ins. diam., bears N75°E, 22.1 ft. dist., with visible scribing. (B.L.M.)

A stump, 29 ins. diam., bears S74°E, 41.6 ft. distant. (G.L.O.) A fallen stump, bears S29°E, 13.4 ft. dist., with visible scribing. (B.L.M.)

A stumphole and remains, bears S16°W, 41.8 ft.dist., with visible scribing. (G.L.O.)

A pine, 14 ins. diam., bears S74°W, 41.9 ft. dist., with a healed face. (B.L.M. rec. S73°W)

A pine snag, 9 ins. diam., bears N40°W, 10.5 ft. dist., with a healed face. (B.L.M.)

A stump, 17 ins. diam., bears N8°W, 29.8 ft. dist., with visible scribing. (G.L.O.)


III. Established three new bearing trees:

A fir, 23 ins. diam., bears N60°E, 31.7 ft. dist., mkd. "T31N R31W S9 BT".

A pine, 12 ins. diam., bears S39°E, 50.6 ft. dist., mkd. "T31N R31W S16 BT".

A fir, 10 ins. diam., bears N41°W, 15.9 ft. dist., mkd. "T31N R31W S8 BT".

Painted red bands around the bearing trees and attached Land Survey Monument and Bearing Tree signs. Magnetic Declination: 20° East
