

## INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

## CERTIFIED CORNER RECORDATION

Corner Cor. No. 6 HES 751 T. 31 North R. 32 West P.M.M. Lincoln County

ORIGINAL - Harold Townsend - 1918 HES 751

Set a small stone marked with a cross "X" under an iron post, 2" diameter, 36" long, 24" in the ground with a brass cap marked 1918 6 HES 751 and a point on top from which:

A cross "X" on a Yellow Pine tree, 8" diameter, bears S72°24'E, 69 links (45.54') distant.

A cross "X" on a fir tree, 10" diameter, bears S55°46'W, 70 links (46.20') distant.

Each blazed and scribed 6 HES 751 BT.

Raise a mound of stone 4' base, 2' high, south of corner.

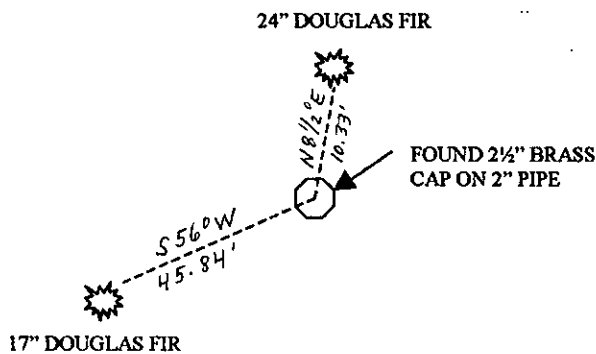
## FOUND:

Found 2½" brass cap marked as shown below on 2" diameter pipe.

A 17" diameter Douglas Fir with blaze and visible scribing and a BLM BT tag bears S56°W, 45.84 feet distant to aluminum nail in side center of tree.

A 24" Douglas Fir with healed blaze bears N8½°E, 10.33 feet distant to aluminum nail in side center of tree.

Paint bearing trees with red paint and attach bearing tree tags.

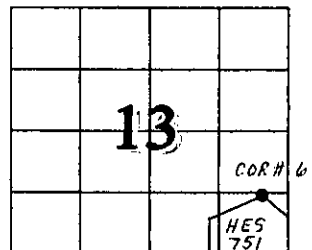
