

CERTIFIED CORNER RECORDATION

Corner Meander Corner S20 & S21 T. 31N R. 33W P.M.M. Lincoln County

1893 Original GLO record by Daniel P. Mumbrue, Book 2828 Page 28:

"Left bank of Kootenai river

Set a post 4 ft. long 4 ins. square 24 ins. in the ground for meander Cor. to Frac. Secs. 20 & 21 marked M.C. on N. face with T31N. on N. R.33W. S.21 on E. and S20 on W. faces, from which

A tamarack 20 ins. diam bears S60°E. 79 lks. dist. marked T31N.R.33W.S21 M.C.B.T.

A tamarack 24 ins. diam bears S56°10'W. 37 lks. dist. marked T31N.R.33W.S20 M.C.B.T."

1997 Remonumentation by Jane L. Eby, 8694ES:

Found a tamarack stump, 24 inches diameter, 36 inches tall. I cut into the healed over face and exposed scribing "BT" and an axe notch. I nailed the face with reverse scribing and notch back on the stump.

As determined from the original bearing tree stump, I set an aluminum pipe, 2 1/2 inches diameter, 30 inches long, with 3 1/4 inch diameter aluminum cap, marked as shown, in a mound of earth and stone, 4 feet diameter, 14 inches tall.

From which I establish 2 new bearing trees:

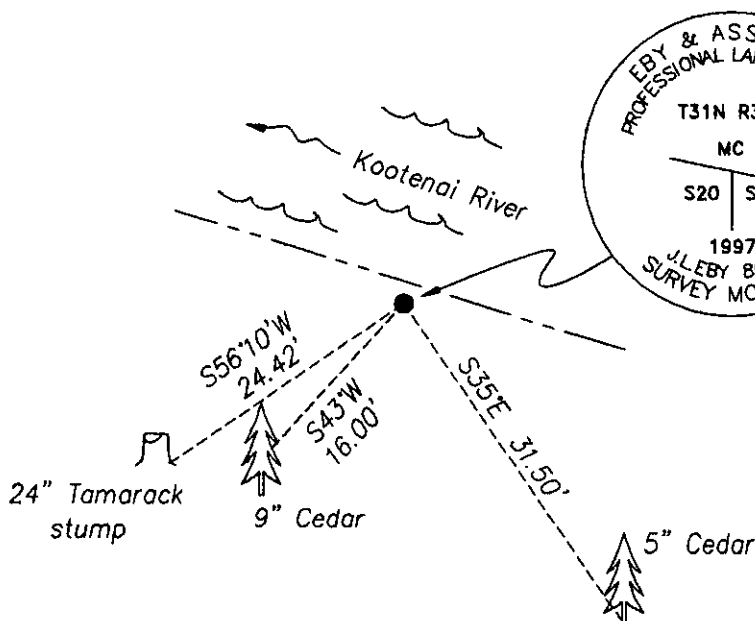
A Cedar, 5 inches diameter, bears S. 35° E., 31.5 feet distance, scribed "X" "BT".

A Cedar, 9 inches diameter, bears S. 43° W., 16.0 feet distance, scribed "T31N R33W S20 MC BT".

I painted blazes and faces red. I attached Land Survey Monument signs to new trees and tamarack stump.

Measurements were made with a steel tape and Silva hand compass using 19° East declination.

See Certificate of Survey No. 2561 for ties to adjacent controlling section corners.
