A fir, 10 ins. dia., bears S18°W, 65 lks (42.9 ft.)
A pine, 20 ins. dia., bears N78°W, 23 lks (15.2 ft.)

1983 Record:
(Hill, 5612S)

Found a 2-1/2 ins. BLM pipe, 4 ins. above ground, with brass cap from which:

A pine, 22 ins. dia., bears N77°W, 15.2 ft., with overgrown blaze.
A fir, 15 ins. dia., bears S20°W, 43.0 ft., with visible scribing.

2010 Found:

We find a 3-1/4 ins. dia., BLM brass cap, marked as shown below from which:

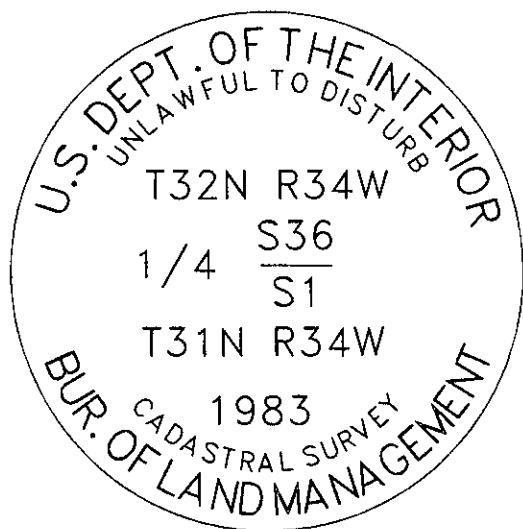
A pine, 27 ins. dia., bears N77°W, 15.2 ft., with a chopped out heel blaze and no visible scribing.
A fir, 16 ins. dia., bears S18°W, 43.0 ft., with an overgrown heel blaze.

2010 Perpetuation:

Bearing trees affixed with BT tags, LSM signs, snow blazed and painted red bands.

Steel spikes driven into BT's, side center at point of measurement.

We set a galvanized steel post West, 1.0 ft from monument, with LSM and USFS boundary decals.
