Red fir, 10 ins. dia, bears N62°W, 101 ft., scribed "W1/16 S36 BT", notched at root crown, painted red band & attached BT sign.
Black pine, 18 ins. dia., bears S36°W, 20.4 ft., scribed W1/16 S1 BT", notched at root crown, painted red band & attached BT sign

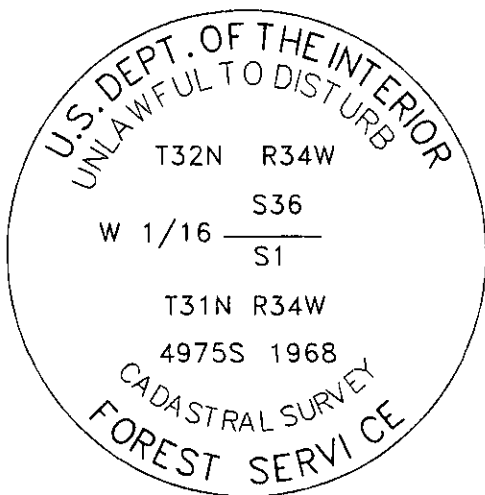
1994 Record: Found a 2-1/2 in. dia. alum. pipe, 6 ins. above the ground, firmly set in a collar of stone
(Hughes 7322 LS) w/ 3-1/4 ins. dia. USDA alum. cap.
From which:
Pine, 20 ins. dia., bears S20°W, 20.6 ft. w/ "6" visible (1986 Record S36°W)
Fir, 10 ins. dia., bears N75°W, 101 ft., w/ "BT" visible (1986 Record N62°W)

2010 Found: We find a 3-1/4 ins. dia. USDA alum. cap on 2-1/2 ins. dia. alum. pipe, as shown below, rising 0.1 ft. from the ground.
From which:
Ponderosa Pine, 23 ins. dia., bears S23°W, 20.6 ft. w/ overgrown blaze & BT tag
Douglas Fir, 10 ins. dia., bears N75°30' W, 101 ft., w/ overgrown blaze & BT tag
Steel fence post, bent & loose, bears West, 2.0 ft., w/ survey decals

2010 Perpetuation: We establish no new reference monuments.

We set a galvanized steel post, West, 2.35 ft. from the monument w/ LSM and USFS boundary decals.

Bearing trees were affixed with BT tags, snow blazed and a painted red band.

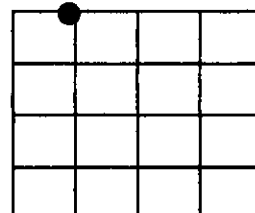
