

CERTIFIED LAND CORNER RECORDATION

(REFERENCE FSH 5681.65)

DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (IF KNOWN)

At the $\frac{1}{4}$ corner common to Sections 24 and 25, T33N, R26W, MPM, Lincoln County, Montana, we find; A stone 5" X 5" and about 4" above the ground, firmly set in the ground with " $\frac{1}{4}$ " scribed on the north face of stone (Record: Set shale stone, 15" X 8" X 6", 10" in ground, marked " $\frac{1}{4}$ " on north face). We find; A pine stump about 6" with readable scribing, S2
BT

bearing 43 links N 60° E of stone (Record: Pine 4", bears N 56° E, 43 links, marked $\frac{1}{4}$ S. 24, BT) There are two land owners, George Tillson and A. T. Mitchell. Mr. Tillson says the stone and other BT were there when he moved here in 1946. The other BT has hence been removed (Record: Pine 5", S 58° W, 92 links, marked $\frac{1}{4}$ S. 25, BT). Both land owners agree the stone is the corner. The stone is set in a fence corner which runs N 88° E and N 2° W.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED
TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

We set two new R.M. trees to preserve this corner as follows: 9" Date of work: 5/24/66
LPP bears N 40 $\frac{1}{2}$ ° E, 131 links from stone, marked "RM" with blazes
at top and bottom, painted red and with bearing tag attached; 12" larch bears S 83 $\frac{1}{2}$ ° W,
2 chains, 44 links from stone, marked "RM" with blazes at top and bottom, painted red
and with bearing tree tags attached. We painted top of stone with red paint. Bearing
tree tag was attached to old bearing tree stump.
