

CERTIFIED CORNER RECORDATION

Corner E 1/4 S4 T 32 N. R. 31 W. P.M.M. Lincoln County

I. Record: 1901 GLO survey by Abram L. Jaqueth: Set a sandstone 30x12x10 ins. 22 ins. in the ground, for 1/4 sec. cor. marked 1/4 on W. face, from which:

- A pine 10 ins. diam., bears N.65°15'E., 14 lks. dist., (9.24 ft), mkd. 1/4 S3 BT.
- A pine, 10 ins. diam., bears S.61°10'W., 10 lks. dist., (6.60 ft.), mkd. 1/4 S4 BT.

II. Found: During a field search of area, no monument or related accessories were found.

III. Perpetuation: At a computed point determined from survey, we set a aluminum pipe, 2 1/2 ins. diameter x 30 ins. long, 24 ins. in the ground with a 3 1/4 inch diameter aluminum cap marked as shown, from which:

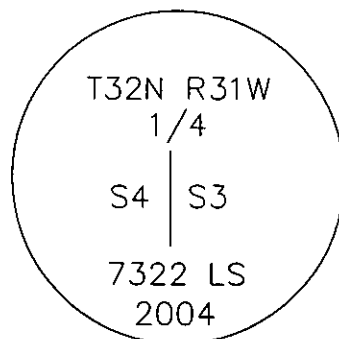
- A pine, 6 ins. diam., bears N.12°E., 20.90 ft. dist., scribed 1/4 S3 BT.
- A pine 7 ins. diam., bears N.74°W., 13.90 ft. dist., scribed 1/4 S4 BT.

Raise a collar of stone 24 ins. diam. around monument.

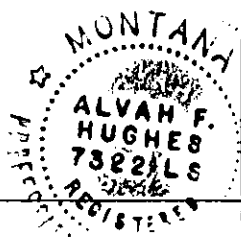
Painted faces and 6 in. wide red bands to all bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic declination: 20° East assumed

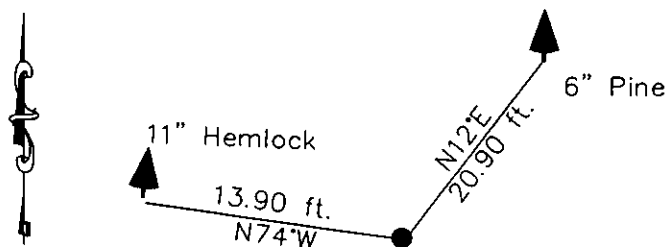

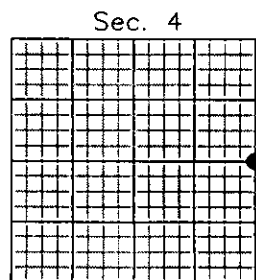
