A larch, 12 ins. diam., bears S67 $1/2^{\circ}$ W, 28 lks.(18.48 ft.) dist., mkd. 1/4 S22 BT. A cedar, 8 ins. diam., bears N44 $1/2^{\circ}$ W, 28 lks.(18.48 ft.) dist., mkd. 1/4 S15 BT.


II. Found a 2 1/2 ins. diam. iron pipe 4 ins. out of the ground with BLM brass cap mkd. as shown.
