

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

Corner 2 of HES 731 T. 32 N. R. 33 W. P.M.M. Lincoln County

- I. 1917 HES 731 record by E. R. Johnson: "Set a small stone, marked with a cross(x) under a basalt stone, 26x10x8 ins., 16 ins. in the ground, marked 2 HES 731 on SW face, and a cross(x) on top for the exact corner point, from which

A cross(x) on a fir, 8 ins. diam., bears $S86^{\circ}45'E$, 12 lks. (7.92 ft.) dist.

A cross(x) on a pine, 8 ins. diam., bears $S46^{\circ}30'W$, 36 lks. (23.76 ft.) dist.

Each blazed and scribed 2 HES 731 BT."

- II. Found a stone, 9x8 ins., 8 ins. out of the ground with 2 HES 731 on SW face.

From which:

A root crown, bears $S86^{\circ}E$, 8.0 ft. dist.

A root crown, bears $S46^{\circ}W$, 23.6 ft. dist.

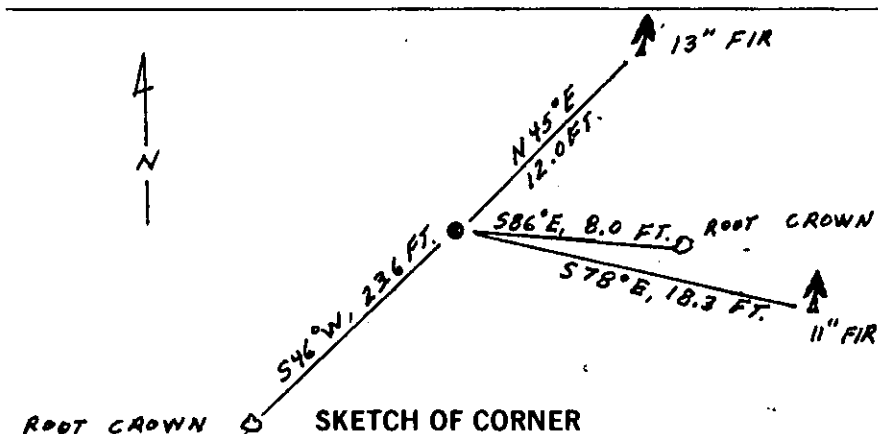
- III. Established two new bearings trees:

A fir, 13 ins. diam., bears $N45^{\circ}E$, 12.0 ft. dist., mkd. 2 HES 731 BT.

A fir, 11 ins. diam., bears $S78^{\circ}E$, 18.3 ft. dist., mkd. 2 HES 731 BT.

Painted red bands around the bearing trees and attached "Land Survey Monument" and "Bearing Tree" signs. Set a galvanized steel gaurd post with "Land Survey Marker" and Property Boundary: decals. West, 3 ft.

Magnetic declination: 20° East

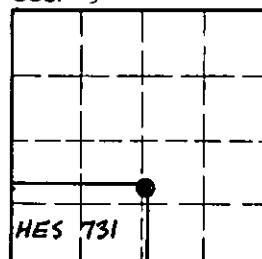
