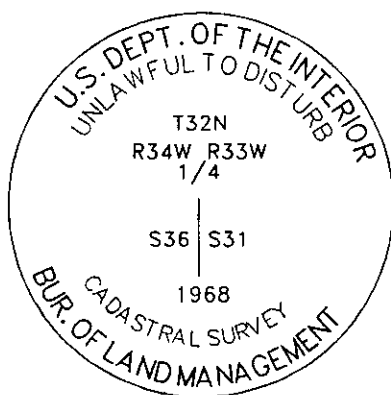

2010 Found: We find a 3-1/4 ins. dia. BLM brass cap, marked as shown below, on 2-1/2 ins. dia. steel pipe, rising 0.5 ft. from a collar of stone.
From which:
Decaying stump, 12 ins. dia., bears N43°30'E, 22.0 ft., visible blaze "BT"
Douglas Fir, 10 ins. dia., bears N56°30'W, 7.3 ft., w/ overgrown scribing, BT tags
Douglas Fir, 14 ins. dia., bears N51°E, 9.2 ft., w/ overgrown scribing, BT tags
Galvanized steel post, bears South, 3.2 ft.
