- 5. Certification must be signed and scaled by Land Surveyor registered in the State of Montana.

Set a 1-1/2 ins. x 30 ins. brass capped pipe, 24 ins. in the ground from which:

A Grand fir, 4 ins. dia., bears S55°E, 5.8 ft., scribed "RM1" A Douglas fir, 14 ins. dia., bears S42°W, 25.0 ft., scribed "RM2"

2010 Found:

We find a 2-1/2 ins. dia. brass cap on 1-1/2 ins. dia. metal pipe set firm, marked as shown below from which:

A Grand fir, 16 ins. dia., bears S55°E, 5.7 ft., with an overgrown heel blaze. A fir stump, 20 ins. dia., bears S42°W, 25.0 ft., with evidence of a heel blaze in the rings.

2010 Perpetuation:

We establish a new bearing tree as follows:


Grand Fir, 8 ins. dia., bears S56°W, 17.2 ft., scribed "1/64 S14 RM"

Bearing trees affixed with BT tags, LSM signs, snow blazed and painted red bands.

Metal spike driven into BT's side center at point of measurement.

Set a galvanized steel post, N36°W, 0.8 ft of the monument with LSM and USFS boundary decals.
