Set a 32 ins. x 3-1/2 ins. dia: alum. pipe, 25 ins. in the ground w/ alum. cap. Raised a collar of stone around monument. From which:

White Pine snag, 24 ins. dia., bears S29°E, 20.0 ft., w/ partially overgrown blaze, scribed "3" Cedar, 14 ins. dia., bears S76°W, 51.8 ft. (Record S73°W), scribed "T31N R34W S4 BT" w/BT tags


2010 Perpetuation:

We establish new reference monuments as follows:

Hemlock, 7 ins. dia., bears S21°E, 21.8 ft., scribed "T31N R34W S3 BT" There are no suitable trees for a BT in Section 33, area has been heavily logged.

We set galvanized steel posts, West, 1.8 ft. and East, 1.85 ft. from the monument w/ LSM and USFS boundary decals.

Bearing trees were affixed with BT tags, snow blazed and a painted red band.
