Set a 1-1/2 ins. x 30 ins. brass capped pipe, 24 ins. in the ground from which:

A Douglas fir, 8 ins. dia., bears N76°E, 8.0 ft., scribed "RM1"

A Douglas fir, 10 ins. dia., bears S37°E, 41.8 ft., scribed "RM2"

2010 Found:

We find a 2-1/2 ins. dia. brass cap on 1-1/2 ins. dia. metal pipe set firm, marked as shown below from which:

A fir, 11 ins. dia., bears N73°E, 8.0 ft., with an overgrown heel blaze.

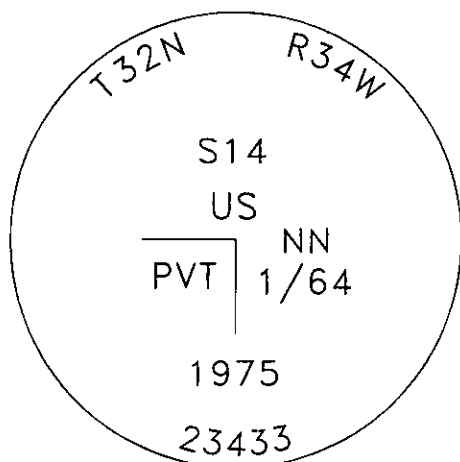
A fir, 13 ins. dia., bears S38°E, 41.8 ft., with an overgrown heel blaze.

2010 Perpetuation:

Bearing trees affixed with BT tags, LSM signs, snow blazed and painted red bands.

Metal spike driven into BT's side center at point of measurement.

Set a galvanized steel post South, 0.5 ft from the monument with LSM and USFS boundary decals.
