Corner: Section Corner; Secs. 35,36,1,2 T.32N. R. 34W. P.M.M. Lincoln County
Section Corner; Secs. 1,2,35,36 T.31N. R. 34W.

1902 GLO Record: Set a limestone, 20 ins. x 8 ins. x 6 ins., 15 ins. in the ground, for cor. of sections 1,2,35 and 36, marked with 1 notch in East and 5 notches on the West edges from which:
A Cedar, 10 ins. dia., bears N72°E, 54 lks (35.6 ft.), marked "T32NR34WS36BT".
A fir, 5 ins. dia., bears S70°30'E, 61 lks (40.3 ft.), marked "T31NR34WS1BT".
A fir, 16 ins. dia., bears S65°W, 40 lks (26.4 ft.), marked "T31NR34WS2BT".
A Tamarack, 24 ins. dia., bears N45°W, 18 lks (11.9 ft.), marked "T32NR34WS35BT".

1979 Record:
(Ninneman, 534S) COS No. 564 depicts a BLM brass cap for the section corner.

2010 Found: We find a 6 ins. x 6 ins. concrete block with a 3/4 ins. square metal bolt embedded in the center. The block is set firm and level with the ground from which:

A treated wood fence post bears West, 3 ft., with a location tag attached dated 4-25-64. Information on the tag places the section corner 3 ft. East.
A galvanized steel post with an LSM decal, bears South, 3 ft.

2010 Perpetuation: Establish new bearing trees as follows:

A Ponderosa pine, 19 ins. dia., bears N5°E, 43.7 ft., scribed "T32NR34WS36BT".
A fir, 13 ins. dia., bears N73°W, 13.1 ft., scribed "T32NR34WS35BT".

Bearing trees affixed with BT tags, LSM signs, snow blazed and painted red bands.

Steel spikes driven into BT's, side center at point of measurement.

We set a galvanized steel post West, 0.5 ft. from monument, with LSM and USFS boundary decals.
