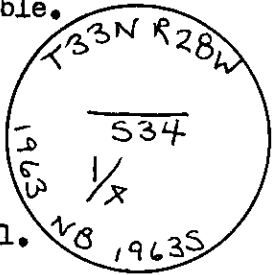
As per corner record card Kootenai National Forest, from found original evidence:

Set a 2"x36" pipe with brass cap in mound of stone. Stone buried alongside pipe.
Marked as shown BELOW:

From which: A 24" pine bears N41°E., 25.1 ft Blazed, but markings not visible.
A 28" pine bears S3°30'E., 9.2 ft Marked: "1/4 S34 BT."
A 9" fir (F.S.R.M.) bears S48°30'W., 157 1/2 lks. New tree.

Found a 2" steel pipe appr. 12" above with collar of stone. Marked as shown:

From which: A 12" fir bears S49°W., 103.76 ft. Healed face, alive and well.
A 23" pine bears S10°E., 9.7 ft. Scribing visible, alive and well.



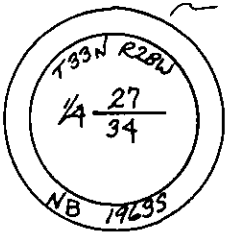

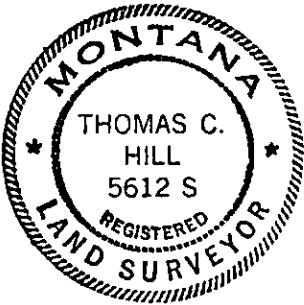
