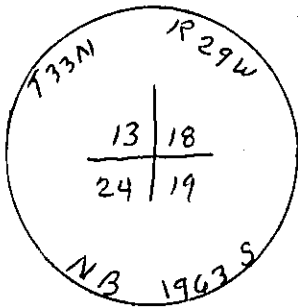

Sec. 18 BT 20" fir as marked (Record - 20" fir marked T33N, R28W, S 18 BT bears N 31°15' E, 65 links). Sec 13 BT 12" fir as described (Record - 12" fir marked T33N, R29W, S 13 BT bears 8°15' W, 90 links). Sec. 19 BT fir as described (Record - 10" fir marked T33N, R28W, S 19 BT bears S 61° E, 16 links). Sec 24 BT 10" fir as described (Record - 10" fir marked T33N, R29W, S 24 BT bears S22° W, 26 links).

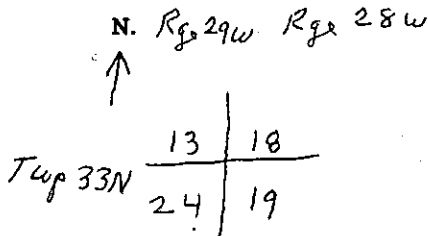
