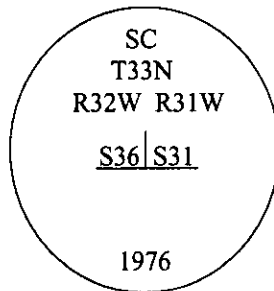


# CERTIFIED CORNER RECORDATION

Corner Sec. Cor. Sec. SW S31 T. 33N R. 31W P.M., MT Lincoln County

- I. 1904 G.L.O. Original Record by Ranney Y. Lyman et. al: Set a limestone, 18x8x6 ins., 12 ins. in the ground, for cor. of T31N, and R31 & 32W, mkd "SC" on N., with 6 grooves on N., E., and W. faces. Established two bearing trees.

1976 B.L.M. Remonumentation Record by Joseph E. French: The Standard cor. of T33N, R31 & 32W, monumented with a limestone, 18x8x6 ins., firmly set, 12 ins. in the ground, mkd. "SC" on the N. and 6 grooves on the N., E. and W. faces, witnessed by the remains of the original bearing trees. At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 24 ins. in the ground, with brass cap mkd. as shown.



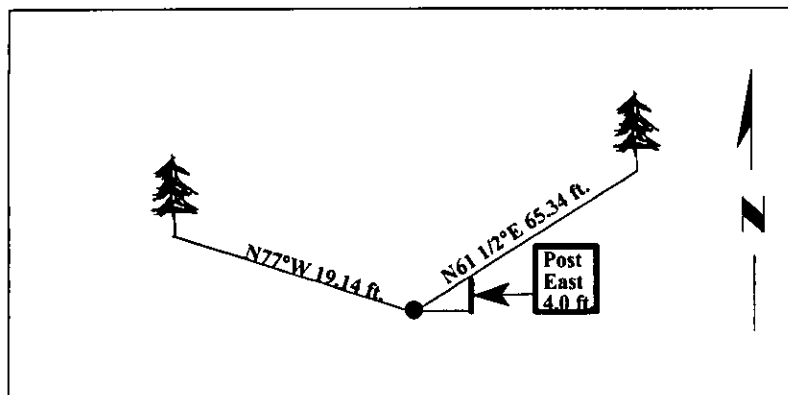
Established two new bearing trees and buried the original stone alongside and raise a flat mound of stone, 3.0 ft. diam., around the iron post.

- II. Found a brass cap, firmly set, with a small rock collar, mkd. as shown above. Found two bearing trees.  
from which:

A fir, 12 ins. diam., bears N61 1/2°E, 65.34 ft. dist., "T33N R31W S31 SC BT" visible. (B.L.M.-record)  
A fir, 15 ins. diam., bears N77°W, 19.14 ft. dist., with a healed face. (B.L.M.-record)

- III. Set a steel galvanized post, East, 4.0 ft. dist of corner, with Land Survey Monument and Property Boundary decals attached.  
Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.  
Attached a location poster to a fir tree on the uphill side of road No. 4604.

Magnetic Declination: 20° East.
