

CERTIFIED LAND CORNER RECORDATION

(REFERENCE FSM 7153.53)

DESCRIPTION OF CORNER EVIDENCE FOUND, AND ORIGINAL RECORD (IF KNOWN)

Orig: Set for Cor. No. 2. a quartzite stone 24x12x6 ins., 14 ins. in the ground, marked 2 H.E.S. 414 on SW. face, and a cross(x) on top for the exact corner point, from which

A cross (x) on a larch, 18 ins. dia., bears S.18°50'W., 22 lks. dist.

A cross (x) on a larch, 14 ins. dia., bears N.16°30'W., 25 lks. dist.; each blazed and scribed 2 H.E.S. 414 BT.

Raise a mound of earth, 4 ft. base, 2 ft. high, SW. of corner.

Note: Original survey was executed using a 31°06' East declination.

Found: Found two larch stumps, one with scribing, at record bearing and distance of described bearing trees. Also found original stone marked as described, lying on its side, at approximate corner position.

DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

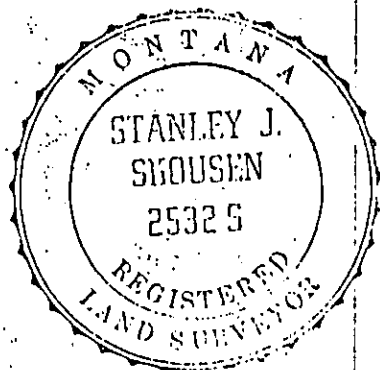
Replaced original stone, firmly in the ground, at exact corner position. Further perpetuated the corner by establishing two new bearing trees.

A 4" fir marked X BT bears S22°30'W 31³ links.

A 12" fir marked X 2 BT bears N71°30'W 48 links.

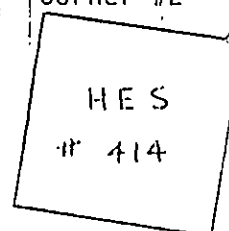
