



CERTIFIED CORNER RECORDATION

Corner	Standard	Sec.	34	T.	33N	R.	34W	P.M., MT	Lincoln	County
	1/4 Cor.									

I. 1903 G.L.O. Record by Allen B. Benedict: Set a granite stone, 15x8x8 ins., 10 ins. in the ground, for standard 1/4 sec. cor., mkd. "SC 1/4" on N. face.

Established two bearing trees:


A hemlock, 6 ins. diam., bears N02°15'E, 23 lks. dist., mkd "1/4 S34 BT". A pine, 10 ins. diam., bears N51°30'W, 25 lks. dist., mkd "1/4 S34 BT".

II. Found stone, 8x8x15 ins. diam., 1 1/2 ins. below the surface of a mound of earth and debris, firmly set, mkd. "SC 1/4" on the North face.

from which:

A rotten hemlock stump, bears N12°E, 15.2 ft. dist., with visible scribing. A fallen rotten log, at approx. record bearing and distance (N51°W, 16.5 ft.) no visible marks.

III. At the exact corner position, as determined by the original found stone and witnessed by the remains of the original bearing trees, set a 30 ins. long, 2 1/2 in. diam. aluminum pipe, 24 ins. into the ground, with a 3 1/4 in. diam. aluminum cap, mkd. as shown.




Established two new bearing trees:

A fir, 11 ins. diam., bears N66°E, 75.3 ft. dist., mkd. "1/4 S34 BT". A larch, 13 ins. diam., bears N15°W, 46.3 ft. dist., mkd. "1/4 S34 BT".

Buried the original stone upside down, alongside the aluminum pipe.

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.
