

- INSTRUCTIONS
1. Original and copy of record used to evaluate the corner position.
 2. Description of monument found, note discrepancies in the record, state method of establishing lost or obliterated corners.
 3. Description of monument and accessories set to perpetuate the corner position.
 4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
 5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
 6. Fill in Cross Index & Section Diagram at bottom of sheet.

RECORD:

No other corner of record was set.

FOUND:

No monuments were found during field search.

MAINTENANCE:

The W 1/16 of Sec. 17 and 20, T. 33 N., R. 34 W., P.M.M., was set by computed location from a sec. breakdown of Sec. 17, T. 33 N., R. 34 W., P.M.M., by Davis Surveying on record in the Lincoln County Courthouse.

At the calculated position, set a 5/8 inch diam. x 24 inch long rebar with a 1 1/4 inch diam. plastic cap stamped: KED 4975S 21 ins. in the ground.

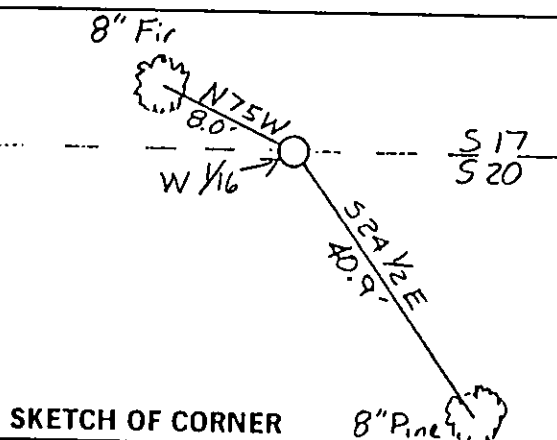
We established two (2) Bearing Trees described as follows:

A 8 inch diam. Fir bears N. 75° W. 8.0 ft. dist. scribed (W. 1/16 S. 17 BT).

A 8 inch diam. Ponderosa Pine bears S. 24 1/2° E. 40.9 ft. dist. scribed (W. 1/16 S. 20 BT).

Painted scribes red and 6 inch red band around both Bearing Trees.

Attached Bearing Tree signs to both trees.

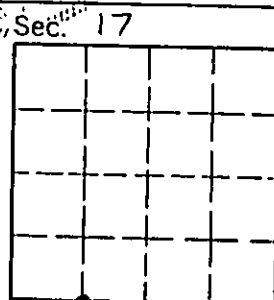
