
## **CERTIFIED CORNER RECORDATION**

Corner Sec. Cor. Sec. 20, 21, T. 34N R. 26W P.M., MT Lincoln County 28&29

I. 1894 G.L.O. original record by Abram L. Jaqueth: Set a wooden post and 4 bearing trees.

1960 B.L.M. remonumentation record by David R. Cunningham: The cor. of secs. 20, 21, 28, & 29, monumented with a disintegrated wooden post, firmly set in the ground, and witnessed by 3 of the original bearing trees.

At the corner point, set an iron post, 30 ins. long, 2 1/2 ins. diam., 26 ins. in the ground, with a brass cap mkd. as shown:



Established four new bearing trees. Raise a mound of stone, 3 ft. base, 2 ft. high, W. of the iron post.

II. Found a 2 1/2 in. iron post, firmly set, protruding 5 ins. above the ground, with a 3 1/4 in. diam. brass cap mkd. as shown above, from which:

Rotten remains, bears N16°E, 17.1 ft. dist., with no visible marks. (G.L.O. rec.)

A larch, 32 ins. diam., bears N75°E, 13.7 ft. dist., mkd. with visible scribing. (B.L.M. rec.)

A larch, 5 ins. diam., bears S64°E, 31.0 ft. dist., mkd. with a healed face. (B.L.M. rec.)

A rotten log, bears S44°E, 21.8 ft., dist., mkd. with an healed face. (G.L.O. rec.)

A larch snag, 6 ins. diam., bears \$20°W, 33.0 ft. dist., mkd. with a healed face. (B.L.M. rec.)

No evidence found of G.L.O. bearing tree at S33°W, 44 lks. dist..

A larch, 7 ins. diam., bears N81°W, 52.8 ft. dist., mkd. with a healed face. (B.L.M. rec.)


A larch stump, bears N66°W, 23.1 ft. dist., mkd. with visible scribing. (G.L.O. rec.)

III. Established one new bearing tree:

A pine, 6 ins. diam., bears S40°W, 20.7 ft. dist., mkd. "X" "BT".

Set a 6 ft. steel guard post, with LSM and PB decals, South, 3.0 feet. Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.


