
I. 1894 G.L.O. orig. record by Abram L. Jaqueth: At 40.09 chains: Set a post, 3 ft. long, 3 ins. square, 24 ins. in the ground, for 1/4 Sec. Cor. marked "1/4 S." on N. face, from which:
A pine, 6 ins. diam., bears N13°30'E, 21 lks. dist., mkd. "1/4 S. BT".

A fir, 10 ins. diam., bears S74°30'W, 27 lks. dist., mkd. "1/4 S. BT".

At 41.37 chains: A larch, 12 ins. diam., on line, mkd. with 2 notches on E. and W. sides.

1987 U.S.F.S. C.C.R. by Alvah F. Hughes: Found a stump hole with a piece of the original pine bearing tree with legible scribing. Two stumps were found at approx, record bearing and dist, for the larch line tree, but log remains were not available. No remains of orig. post were found.

At record bearing and dist. from remains of the orig, pine bearing tree, set an aluminum post, 2 1/2 ins. diam., 30 ins. long, 24 ins. in the ground, in a mound of earth and stone, 3x3x1 ft. high, with a 3 1/4 in. diam. aluminum cap mkd. as shown:



Established two new bearing trees.

Set a steel guard post with a "Survey Marker" decal attached, 2 ft. E. of the monument.

II. Found a 2 1/2 in. alum. post, firmly set, protruding 4 ins. above the ground, with a 3 1/4 in. diam. alum. cap mkd. as shown above, from which:

A fir, 8 ins. diam., bears S6°E, 10.8 ft. dist., mkd. with visible scribing. (U.S.F.S. record) A larch snag, 7 ft. high, 10 ins. diam., bears N77°W, 23.9 ft. dist., mkd. with visible scribing. (U.S.F.S. record)

No evidence of orig. bearing trees found.


A steel guard post with a survey Marker decal attached, 2 ft. E. of the monument.

III. Established one new bearing tree:


A fir, 7 ins. diam., bears N35°E, 14.9 ft. dist., mkd. "1/4 S21 BT".
