

## INSTRUCTIONS

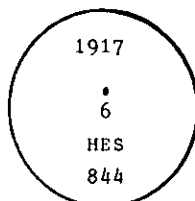
1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

## CERTIFIED CORNER RECORDATION

Corner 6 of HES 844 T. 34 N. R. 33 W. Lincoln County

I. 1917 HES original record by E. R. Johnson: "Cor. No. 6 of this survey as follows:

Set a small stone, marked with a cross (X) under an iron post 2 ins. diam., 36 ins. long, 24 ins. in the ground, with a brass cap marked:



and a point on top for the exact corner point, from which:

A cross (X) on a white pine tree, 20 ins. diam., bears  $N.75^{\circ}30'W.$ , 36 lks. dist.

A cross (X) on a white pine tree, 15 ins. diam., bears  $N.48^{\circ}30'E.$ , 35 lks. dist.

each blazed and scribed 6 HES 844 BT.

Raise a mound of stone 4 ft. base, 2 ft. high, NE. of corner."

II. Found a 2 ins. diam. iron pipe, protruding 4 ins. out of the ground, with a Forest Service brass cap, mkd. as shown above. No bearing trees found, due to logging road.

III. Established two new bearing trees:

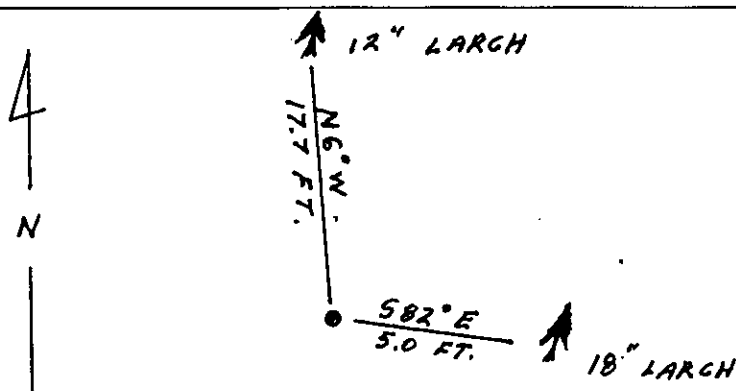
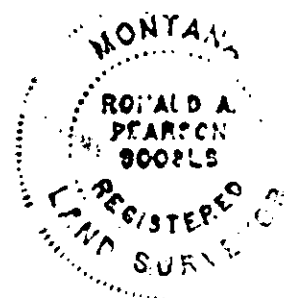
A grand fir, 12 ins. diam., bears  $N.6^{\circ}W.$ , 17.7 ft. dist., mkd. 6 HES 844 BT.

A larch, 18 ins. diam., bears  $S.82^{\circ}E.$ , 5.0 ft. dist., mkd. 6 HES 844 BT.

Painted red bands around the bearing trees and attached "Land Survey Monument" and "Bearing Tree" signs.

Set a galvanized steel guard post with "Land Survey Marker" and "Property Boundary" decals,  $N.59^{\circ}E.$ , 3 ft. dist. from corner.

Magnetic declination:  $20^{\circ}$  East

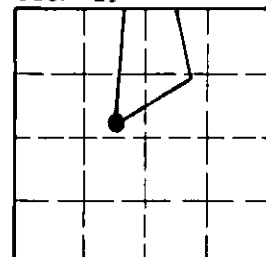
