

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

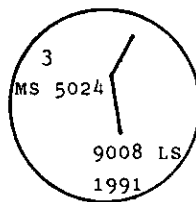
Corner 3 of MS 5024 T. 34 N. R. 33 W. P.M.M. Lincoln County

- I. 1896 MS original record by Abram L. Jaqueth: "Second Course, S.10°10'W. Along the right bank of Yaak River. Set a post 5 ins. square, 4 ft. long, 2 ft. deep, marked 3-5024 for Cor. No. 3.
A blazed pine tree, 10 ins. in diam., marked 3-5024 BT, bears S.74°10'W., 14 ft. dist.
A blazed white pine tree, 14 ins. in diam., marked 3-5024 BT., bears N.30°35'W., 25 ft. dist."

II. Found no corner monument and no accessories.

III. At position determined by grant boundary adjustment between corners 2 and 5.

Set a 3/4 ins. diam., 30 ins long aluminum rod, 24 ins. in the ground with aluminum cap mkd. as shown:



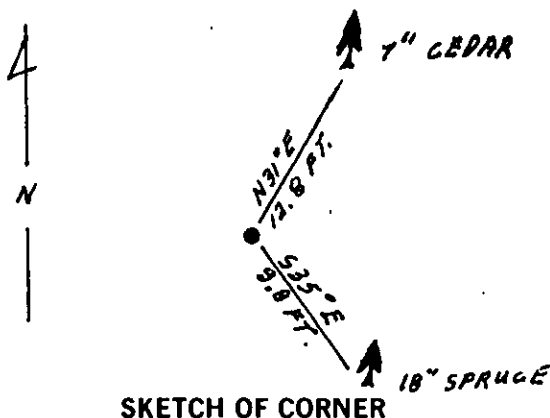
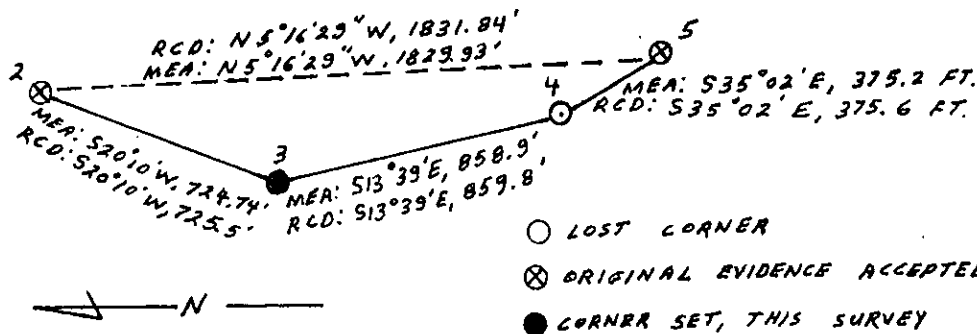
Established two new bearing trees:

- A cedar, 7 ins. diam., bears N.31°E., 12.8 ft. dist., mkd. 3 MS 5024 BT.
A spruce, 18 ins. diam., bears S.35°E., 9.8 ft. dist., mkd. 3 MS 5024 BT.

Painted red bands around the bearing trees and attached "Land Survey Monument" and "Bearing Tree" signs.

Set a galvanized steel guard post with "Land Survey Marker" and "Property Boundary" decals, S.13°E., 3 ft. dist. from corner.

Magnetic declination: 20° East

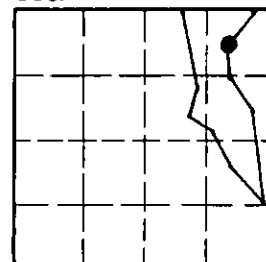
