

T. _____R. ____P.M.M. 5 of MS 5024 Lincoln Corner_ _County 1896 MS original record by Abram L. Jaqueth: "Fourth Course, S.35 02'E. Along the right bank of Yaak River. Set a post 6 ins. square, 5 ft. long, 2 ft. deep, marked 5-5024 for Cor. No. 5. A blazed hemlock tree, 9 ins. in diam., marked 5-5024 BT, bears S.600'W., 16.1 ft. dist. A blazed tamarack tree, 16 ins. in diam., marked BT 5-5024, bears West, 17 ft. dist."

- Found a 1 in. diam. water pipe, 2 ft. long, surrounded by a mound of stone 2 ft. diam. base, 1 ft. high. A larch stump, 4 ft. high, 20 ins. diam., bears West, 17.5 ft., mkd. 5.
- III. Replaced found water pipe with a 3/4 ins. diam., 30 ins long aluminum rod, 24 ins. in the ground with aluminum cap mkd. as shown:



Established two new bearing trees:

A cedar, 6 ins. diam., bears 5.44° W., 10.5 ft. dist., mkd. 5 MS 5024 BT. A spruce, 12 ins. diam., bears $N.66^{\circ}$ W., 11.4 ft. dist., mkd. 5 MS 5024 BT.

Painted red bands around the bearing trees and attached "Land Survey Monument" and "Bearing Tree"

Set a steel guard post with "Land Survey Marker" and "Property Boundary" decals, S.8 E..
