
## INSTRUCTIONS

## **CERTIFIED CORNER RECORDATION**

Corner 6 of H.E.S. 1135 T. 35 N., R. 32 W., P.M.M. Lincoln County 1922, H.E.S. original record by J. F. Pfau: "Place a small stone marked with a cross (x) under a granite stone 24x14x12 ins., 14 ins. in the ground, marked 6 HES 1135 on SE face, and a cross (x) on top for the exact cor. point, from which

A cross (x) on a lodgepole pine tree, 12 ins. dia., bears  $844^{\circ}40^{\circ}E$ , 35 lks. dist. A cross (x) on a lodgepole pine tree, 14 ins. dia., bears  $884^{\circ}15^{\circ}W$ , 18 lks. dist., each blazed and scribed 6 HES 1135 BT.

Raise a mound of earth and stone 4 ft. base, 2 ft. high SE of Cor."

II. Found, a firmly set stone, 12x8 ins., 7 ins. out of the ground, marked 6 HES 1135 on the SE face, from which

A lodgepole pine stump, 15 ins. dia., bears  $886^{\circ}$ W, 12.2 ft. (18.5 lks.) dist., scribing 6 HES 1135 BT is visible.

Position for the SE bearing tree falls in a skid road.

III. Establish two new bearing trees:

A larch, 11 ins. dia., bears  $824^{\circ}W$ , 12.5 ft. dist., scribed 6 HES 1135 BT. A subalpine fir, 10 ins. dia., bears  $884^{\circ}W$ , 25.0 ft. dist., scribed X BT.

Painted red bands around the bearing trees and attached Land Survey Monument and Bearing Tree signs. Set a 6 ft. galvanized steel guard post with Land Survey Marker and Property Boundary decals, south, 5 ft.

Magnetic Declination: 20 30' East
