

CERTIFIED CORNER RECORDATION

Corner No. 1 HES 408 T. 35 N., R. 32 W., P.M.M. Lincoln County

Record :

1915 HES 408 by F.B. Thieme

"Set a small stone, marked with a cross (x) under a sandstone 28x13x4 ins., 18 ins. in the ground, marked 1 HES 408 on E face, and a cross (x) on top for exact corner point, from which:

A cross (x) on a Lodgepole Pine tree, 9 ins. dia., bears N 63°20' W, 16 lks. dist.
A cross (x) on a Lodgepole Pine tree, 10 ins. dia., bears N 11°53' E, 18 lks. dist.,
each blazed and scribed 1 HES 408 BT.
Raise a mound of stone, 4 ft. base, 2 ft. high, E of corner."

Found Evidence :

A sandstone 11x3 ins., 12 ins. exposed above ground, marked 1 HES 408 on the E face with a cross (x) on top, from which:

A well rotted Lodgepole Pine bears N 59° W with a visible scribed face, no dist. was measured due to being able to determine the exact original position.

A mound of stone, 3 ft. base, 2 ft. high, bears NE of corner.

Perpetuation :

I accept the marked stone for Corner No. 1 HES 408.

We established two (2) new Bearing Trees described as follows:

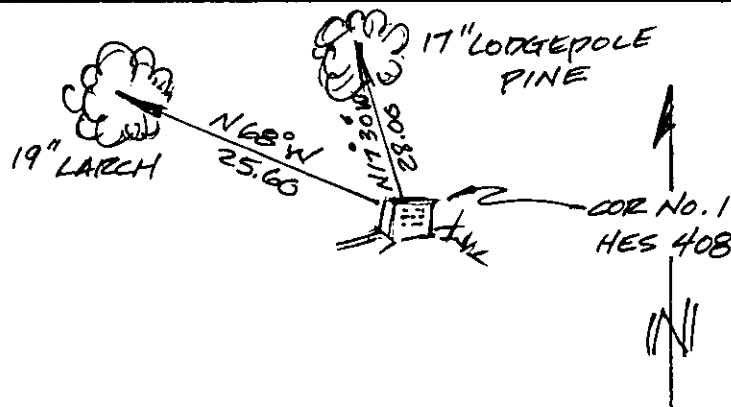
A Lodgepole Pine 17 ins. dia. bears N 17°30' W, 28.00 ft. dist., scribed "1 HES 408 BT".
A Larch 19 ins. dia. bears N 68° W, 25.60 ft. dist., scribed "1 HES 408 BT".

Painted scribed faces red and 6 inch wide bands around both Bearing Trees.

Attached Land Survey Monument and Bearing Tree signs to both trees.

Set a steel post on line 3 ft. SE of corner with attached monument and property line stickers.

Magnetic Declination: 19° East

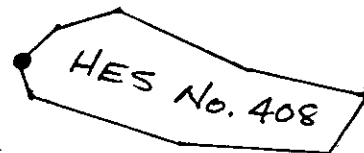
