

CERTIFIED CORNER RECORDATION

Corner No. 7 HES 408 T. 35 N., R. 32 W., P.M.M. Lincoln County

Record :

1915 HES No. 408 by F.B. Thieme

"Set a small stone marked with a cross (x) under a shale stone 28x13x4 ins., 18 ins. in the ground, marked 7 HES 408 on N. face, and a cross (x) on top for the exact corner point, from which:

A cross (x) on a lodgepole pine tree, 9 ins. dia., bears N. 46°30' E., 31 lks. dist.

A cross (x) on a lodgepole pine tree, 11 ins. dia., bears S. 70°28' E., 33 lks. dist., each blazed and scribed 7 HES 408 BT.

Raise a mound of stone, 4 ft. base, 2 ft. high N. of corner."

Found Evidence :

A shale stone 15 x 3 1/2 ins. 12 ins. exposed above ground marked 7 HES 408 on the N. face with a cross (x) on top, from which:

A 11 inch dia. lodgepole pine stump with visible scribing bears N. 46°E., 20.50 ft. dist.

A lodgepole snag fallen over with visible scribing bears SE of stone monument, no distance was measured, due to being able to determine exact original position.

A mound of stone, 4 ft. base, 2 ft. high, bears N. of monument.

Perpetuation :

I accept the marked stone for Corner No. 7 HES 408.

We established two (2) new bearing trees described as follows:

An alpine fir 5 1/2 ins. dia. bears S. 89° E., 9.40 ft. dist., scribed "7 HES 408 BT".

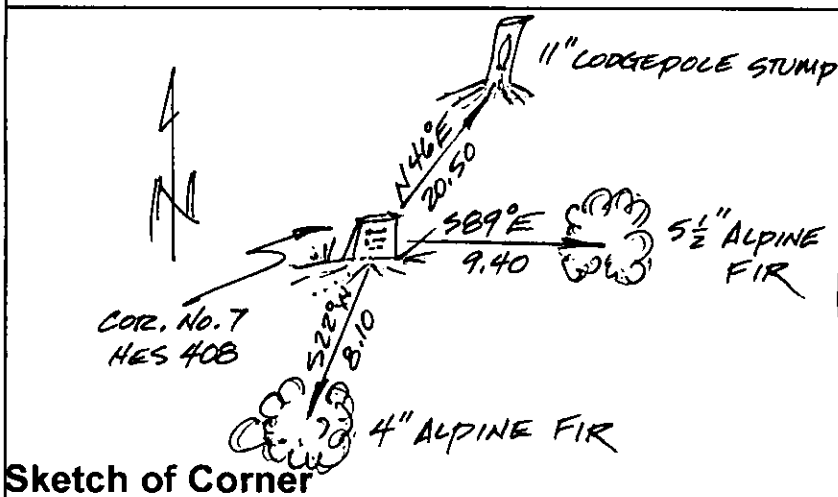
An alpine fir 4 ins. dia. bears S. 22° W., 8.10 ft. dist., scribed "BT" at the base, with a scribed "x" chest height.

Painted scribed faces red and 6 inch wide red bands around both trees.

Attached Land Survey Monument and Bearing Tree signs to both trees.

Set a steel post 3 ft. NW of corner with attached monument and property line stickers.

Magnetic Declination: 19° East

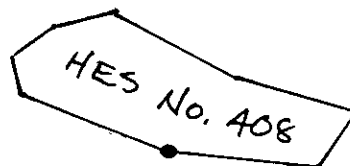
