

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION.

Corner 3 of HES 1071 T. 35 N. R. 33 W. P.M.M. Lincoln County

- I. 1921 H.E.S. original record by Grant Higgins: Placed a small stone, marked with a cross (x) under a granite stone, 24x8x6 ins., 14 ins. in the ground, marked 3 HES 1071 on SW face and a cross (x) on top for the exact corner point, from which.

A cross (x) on an alder tree, 4 ins. dia., bears S39°09'W, 26 lks. (17.16 ft.) dist.

A cross (x) on an alder tree, 4 ins. dia., bears N7°23'W, 18 lks. (11.88 ft.) dist.

Each blazed and scribed 3 HES 1071 BT.

Raise a mound of stone, 4 ft. base, 2 ft. high, SW of corner.

- II. Found a 12x8 ins. stone, firmly set, protruding 9 ins. out of the ground, mkd. 3 HES 1071 on SW face and a cross on top. Mound of stone, 3 ft. dia., 1 ft. high, SW of corner.

No evidence of bearing trees found.

- III. Established two new bearing trees

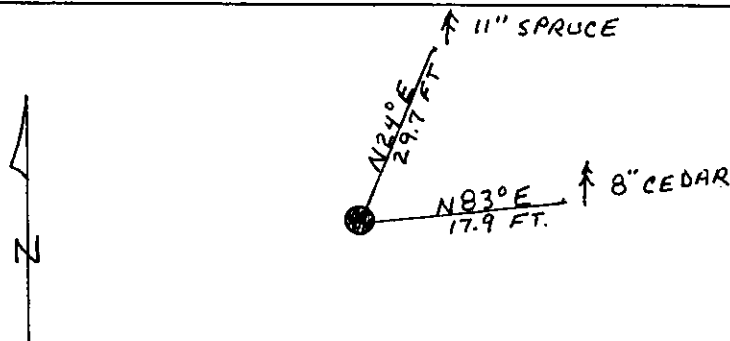
A spruce, 11 ins. dia., bears N24°E, 29.7 ft. dist., mkd. 3 HES 1071 BT.

A cedar, 8 ins. dia., bears N83°E, 17.9 ft. dist., mkd. 3 HES 1071 BT.

Painted red bands around the bearing trees and attached Land Survey Monument and Bearing Tree signs.

Set a 6 ft. galvanized steel guard post with Land Survey Marker and Property Boundary decals, S3°W, 3 ft.

Magnetic declination: 20° East.

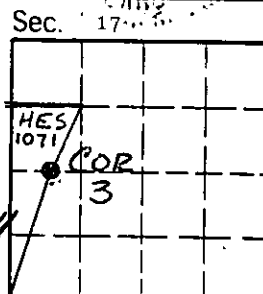
