A 13" douglas fir bears N36° W., 44.2 ft. Healed face, alive and well.

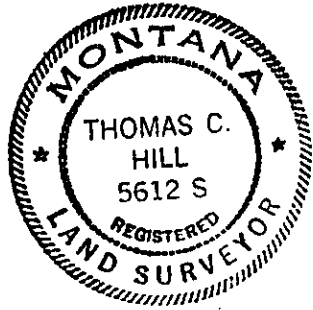

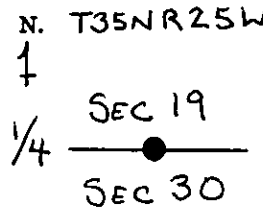
